Ignitability of upholstered seating BS 5852:2006 (Clause 11 Crib 5)

This test is referred to in BS 7176:2007 (Medium hazard).

Description of tested materials as declared by the client

Cover material

Nemofire, composition 44 % CO - 56 % PL, mass per unit area 660 g/m2.

The cover has been treated with a fire-retardant chemical, the exposed surface of the cover was tested.

Filling material (supplied by Laboratory as requested by the client)

Polyurethane foam CM 25 produced by Orsa Foam S.p.A. Company, density 25 kg/m3.

Pre-treatment

The cover has been subjected to the water soaking and drying procedure (Annex E) prior to being conditioned has set out in Clause 10.1.2.

Conditioning

At least 96 hours at 23 \pm 2 °C temperature and 50 \pm 5 % relative humidity.

Requirements

BS 5852:2006, Clause 11.
